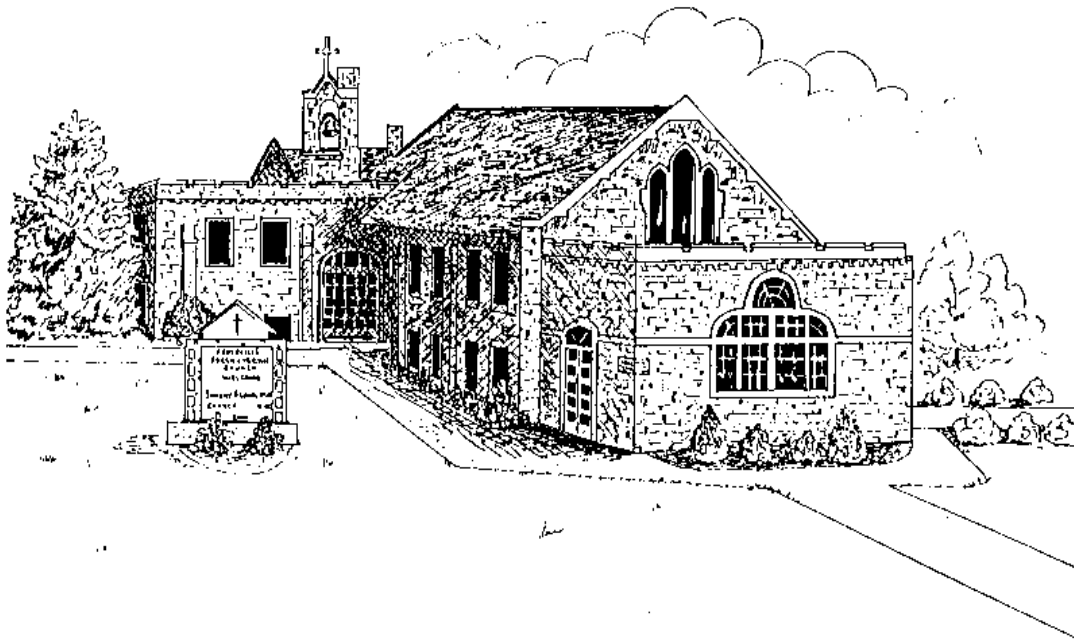

# Pastor's Report

2024 was an eventful year for Huntsville Presbyterian Church!

In Worship we spent time considering a variety of themes from the Scriptures, many of them introspective. Lent offered us lessons in discipline, as we pondered The Practices of the Penitent. After Easter, we thought about what makes for a Church, and all summer we reflected on the refractions of our space, looking that the symbols in the leaded glass that were chosen to anoint our worship space. In late fall, we spent a month studying the wisdom of the Book of James. Advent gave us the start of a new liturgical year and the hope to "Begin Again," as we looked at four visions of the Nativity in the Scriptures. With a thick preaching calendar set for us in 2025, I hope we continue to look to the Holy Scriptures for more ways to grow.

Speaking of growth, we also had a book study of M. Craig Barnes' *Hustling God*. Our conversations have carried over into the first few months of this year. This began after our Confirmation Class ended. For a couple months, I had the privilege of meeting with a group of five teens to talk about the basics of faith, theology, and what it means to be a life-long disciple of Jesus Christ. Some of these had grown up here, but three were new to our community.

Most exciting of all was the celebration of our congregation's 200<sup>th</sup> Anniversary. Beginning back in September of '23, we began sharing monthly "updates," the baptism and membership records, eventful notes from Session minutes, any relevant information we could find from "this month in our history." I found a lot of these dates and facts by going through our records, but it was Matt Zarnosky who brought the color, sharing great stories of our past that he gleaned in doing *mountains* of reading through narratives, old articles, and boxes of collected history. A special sermon series coincided with our birthday month, reminding us that who we are is, in part, a product of the faithfulness of the generations that have preceded us in this place. In late September, we made a day of it, celebrating with an afternoon of fellowship and food. Truly we have much to be thankful for!

And now, we have the future to look forward to. The gifts of the Church Past have equipped us, the Church of the Present, so we can build the Church-to-Come. Let us work with joy as we join the saints of all Huntsville's ages to build the Kingdom together.

## **Finance Committee**

The church finances increased in 2024 for the general fund and decreased for the investment accounts. The general fund account increased by 84% (\$20,770) and the investment accounts decreased 1.5% (\$7,028), due to moving funds from the investment to the general fund. The overall finances have increased 2.7% (\$13,742) due to the special donations and an increase in the investments.

In our annual review with Dodds Wealth Advisors for our 2 investments accounts, we decided not to change the funds since both investments are low risk and have had good returns in previous years.

The financial audit for 2023 was completed. Thank you to Matt Zarnosky for helping with the audit.

UCS Food Pantry provides 3 plus days of food each visit. Recipients may visit the pantry once per month. For the last several years, UCS Food Pantry has been able to provide additional food to recipients at Easter (a ham), Thanksgiving (a turkey) and Christmas (a ham). The remaining cost for these special items has occasionally donated by local residents, thus reducing the impact to our reserve account.

Total food distributed to recipients equals 15,000 days of food to those in need in the Indian Lake area (over 85,000 pounds of food this year). Expenses include food purchased from Second Harvest Food Bank in Springfield and local grocery stores, non-perishables (soap and toilet paper) purchased from grocery stores, rent for our space in the Russells Point Municipal Building, and liability insurance.

UCS Food Pantry wishes to thank everyone for their financial and food contributions. Many people in our area need help to provide nutritious food for themselves and their families. Without you, we would not be able to continue this outreach.

- Financial donations may be mailed to P.O. Box 56, Russells Point, OH 43348.
- Food donations may be dropped off at the pantry during distributions hours. (12:00 pm to 3:00 pm, 2nd and 4th Thursdays of each month.)
- The pantry is in the rear portion of the Russells Point Municipal Building.
- The food pantry is open two times a month on the second and fourth Thursday from 12 until 2.
- Food is delivered from Second Harvest on the Wednesday before we are open. If you would like to help unload deliveries or working at the pantry, please contact Joyce Gordon.
- THANK YOU to everyone who donates food items to the pantry. A basket is in the foyer for the items.

Volunteers are always needed, too! Stop by during distribution hours to see how the pantry works. We have a great group and would welcome new helpers.
